5 Project Background

The Office of the United Nations High Commissioner for Refugees was established on 14 December 1950 by the United Nations General Assembly. UNHCR leads international action to protect people forced to flee conflict and













persecution and those denied a nationality. Its primary purpose is to safeguard the rights and well-being of refugees. It strives to ensure that everyone can exercise the right to seek any time. In delivering its mandate, UNHCR collaborates with governments, civil society and humanitarian organizations, as well as UN agencies and other partners. In Libya, UNHCR provides a range of assistance services to refugees/asylum seekers, IDPs and host communities within the context of the United Nations Sustainable Development Cooperation Framework (UNSDCF), an agreement between the UN Country Team and the Libyan Government that determines and reflects the UN development system's contributions in the country and to support Libya to achieve Sustainable Development Goals. Close collaboration with various UN agencies and NGO actors in different sectors are undertaken to ensure coordination and area-based planning to benefit refugees, returnees, IDPs, stateless persons and host communities. UNHCR's multi-year (2023-2025) strategy addresses the various protection risks, humanitarian and durable solutions needs of Internally Displaced People (IDPs), IDP returnees and host communities, in a comprehensive, effective, and coordinated manner. The strategy has been developed through an inclusive and participatory process, bringing together a wide range of relevant stakeholders, and informed by the findings from various needs assessments undertaken by UNHCR and partners over the past years. Notable progress has been made towards the resolution of internal displacement which is expected to continue in 2024 and beyond. The number of IDPs, as reported by IOM's Displacement Tracking Matrix (DTM), decreased from 316,000 in October 2020 to an estimated 134,787 people by September 2022, largely due to the improved security situation. This marked a 57% reduction in the number of IDPs since the ceasefire agreement, with most IDPs reporting they returned to their places of origin due to the improved security situation. Multi-agency analysis also suggests that a plateau may have been reached with a number of IDPs unwilling to return, in part because they have better access to services and economic opportunities in urban areas or due to the destruction of their homes, or they may have found a durable solution by way of integration into new communities. However, damage to houses and infrastructure as well as limited access to services in areas of origin remain key obstacles to return for the remaining residual group of IDPs. It is anticipated that the IDP population will continue to decrease over the next three years and that by 2025, a residual number of IDPs, not exceeding 40,000, will remain displaced and unable to return to their areas of origin Only some IDP communities from specific profiles will remain at a higher risk of not attaining a durable solution and as such require targeted support and advocacy to support their attainment for a durable solution of their preference. UNHCR will support collective efforts aimed at addressing both immediate and longer-term needs of IDPs, including attainment of durable solutions, and IDP returnees through the implementation of appropriate interventions related to protection monitoring and reporting, referral for legal assistance, shelter and core relief items support, cash assistance and Quick Impact Projects.

Outcome Area: OA8: Well-being Outcome Statement: IDPs, and IDP returnees with heightened risk or vulnerability can meet their basic needs. Outcome Area: OA9: Housing Outcome Statement: IDPs and IDP returnees have increased access to individual shelter opportunities. Impact Area: IA3: Empower Impact Statement: IDPs and IDP returnees have a strengthened environment for peaceful coexistence and social cohesion, and better access to livelihood opportunities. Outcome Area: OA7: Community Outcome Statement: Host and displaced communities have strengthened capacity and greater interest in supporting peaceful coexistence and empowerment of displaced and host communities. A concept note can be submitted for one or multiple locations. UNHCR reserves the right to accept a proposal in whole or in part.
