## GENERAL PROCUREMENT NOTICE (GPN)

- 1. The Government of Libya (GOL) has received financing from the African Development Bank and the African Development Fund (As Administrator of MIC-TAF Trust Fund) toward the cost of the "Strengthening the Regulatory, legislative and Strategic water framework project)"
- 2. The project aims to assess and improve the regulatory, legal, institutional, and strategic water sector framework that will strengthen the control and sustainable management of diminishing water resources, particularly scarce groundwater resources. This will set the basis for a long-term water strategy 2025-2050 that will: (i) minimize the deficit in the water budget, (ii) raise the level of institutional performance; (iii) respond to a changing climate, (iv) manage and reduce development impacts on the environment; (v) maintain and improve biodiversity and the ecosystem; (vi) manage and reduce water losses; (vii) resolve long term water allocation issues and ultimately, (viii) contribute to sustainable economic growth.
- 3. The project components are:
  - Component 1. Assessment of the water governance framework. An international firm will be competitively recruited in order to obtain the following outputs: (i) assessment of the strategic framework and revision of the current water strategy; (ii) assessment of the legal and regulatory frameworks; (iii) assessment of the institutional framework; (iv) preparation of the draft national water policy; (v) preparation of the Country Environmental and Social System Assessment and (vi) elaboration of recommendation's report.
  - · Component 2. Water Strategic Forum. A forum will be organized with the participation of all relevant authorities and experienced individuals from inside and outside the country to shed light on the elements of the strategy and come up with practical and implementable recommendations
  - · Component 3. Project Management. This component includes activities associated with Project Management Team for the day-to-day management, Technical Advisory Committee, capacity building training, and project implementation, monitoring, and evaluation. An external audit will be recruited.
